

What actually happened?

The Internal Market and Consumer Protection Committee's suggestions & resolutions from the European Parliament include:

- Ensuring that products are designed to be robust, easily repaired and upgraded,
- Consumers should have the option of going to an independent repairer: technical, safety or software solutions which prevent repairs from being performed, other than by approved firms or bodies, should be discouraged,
- Member states should consider offering "appropriate incentives" for durable products which can be repaired, boosting repairs and second-hand sales this could help to create jobs and reduce waste,
- Parts which are crucial to the functioning of the product should be replaceable and reparable;
- Essential components, such as batteries and LEDs, should not be fixed/glued into products, unless justified for safety reasons
- Spare parts essential to the functioning of the goods should be made available "at a price commensurate to the nature and life-time of the product"; economic operators should clearly indicate whether spare parts are available or not, on what terms and for how long,



What new law means?

- Firmware must be made available by manufacturers for new mainstream Servers & Storage products as of March 2021
- Firmware Updates will be "free of charge or at a fair, transparent and non-discriminatory cost."
- Security updates will always be free of charge
- Firmware must be made available up to min. 8 yrs post Last Sale
- A data deletion option will need to be provided by the OEM, either embedded or downloadable.
- Fast review: since progressive elements are introduced, the review process of the directive will already start in 2021.
